

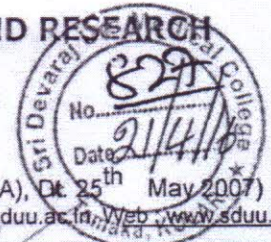

In response Dr.B.G.Ranganath, Professor, Dept. of community medicine was identified as the coordinator of the IQAC. Registrar following this informed that the Academy would notify the IQAC details without further delay.

Members felt that the IQAC should be provided with necessary support staff and other facility for its functioning as it would be playing central role in preparing AQAR as required by NAAC, subsequent to accreditation.


Registrar informed that, all such requirements would be met with. Further, he added that Logos had been received and one of them should be selected as logo for IQAC. With the consent of the members present one logo was selected.

Registrar reiterated the role of IQAC in the monitoring of quality initiatives and sustenance. He said that IQAC would be able to play an important in the documentation process on the quality initiatives. He added that as a deemed to be university there should be emphasis on post graduates and Ph.D. programs and those to be linked with high quality research work and publications.

The faculty should be able to focus on generating extramural funds for research which had been a major setback recorded in the last NAAC report.

Registrar said that, the IQAC functioning should be a priority and it would be able to look in to the shortcomings, observations and suggestions of NAAC team to identify the areas of concern for further improvements for better grading.
