


The Chairman welcomed all the members and invited the IQAC coordinator to initiate the proceedings of the meeting.


### Review of the proceedings of previous meeting

# Review on the progress of preparation for NABL accreditation of diagnostic laboratory

The chairman informed the central diagnostic facility comprising microbiology, biochemistry and pathology had planned for NABL accreditation and in this regard he added that quality related measures were in place for obtaining the accreditation. He said that review meetings with the NABL accreditation task team of the laboratory reviled that the preparedness to undergo NABL accreditation was commendable. He informed the members that NABL accreditation team would be invited for assessment of the laboratory preferably in the month of January. Members discussed on the need for accreditation of diagnostic laboratory complimented the preparedness.

# Workshop on Question paper setting and generation of question papers using software

Chairman informed that, the Academy was contemplating on the feasibility of generation of question paper for the examinations in a highly transparent manner without much of human intervention. He said that, substantial advancements had been achieved already and one senior faculty member of the Academy had enunciated interest in developing software which would enable the examination section to generate question paper based on a blueprint. He added that, one of the prerequisites was structured and validated and questions on each subject. In view of this he said that there was a need to conduct workshop on question paper setting which would match to the requirements for generation of question papers with the help of the software. There were extensive discussion on the intricacies of the process and members felt it the initiative highly innovative and endorsed the decision of the academy to go ahead with the proposal.

## Update on QS I-GUAGE accreditation



He said that it is an initiative by ERA foundation (Education Rating and Assessment) involving international accreditation agency (Quacquarelli Symonds) for assessment and accreditation of Indian Universities.
