Review of the NABL accreditation team visit report and compliance

The chairman informed the central diagnostic facility comprising microbiology, biochemistry and pathology had undergone for NABL accreditation team visit on 17th and 18th February 2018 and in this regard he said that the team visit was highly satisfactory. He added that during the exit meeting of the NABL accreditation team with the management of the academy there were words of appreciation on the overall performance of the laboratory as well as on the scope of securing accreditation for the diagnostic lab.

Further he informed the members of the cell that there were a few non-compliances to be attended to. He said that the report on non-compliances had to be submitted to NABL with in 30days of the receipt of the team visit report and assured the cell that the academy would be able to submit the details within the time allotted as the laboratory had already taken of the remedial actions.

Resolution:

The members of the cell after discussion appreciated the efforts of the academy in successfully conducting NABL accreditation team visit and further the efforts being taken for remedying the non-compliances.

Sensitization on hospital safety aspects for the supporting staff

Chairman informed that, R.L.Jalappa Hospital and Research Centre had obtained entry level NABH accreditation 07-12-2016 and the next task was to obtained full accreditation with in the time frame as put forth by NABH. In view of this he suggested that lot more to be done and the functioning and performance of the hospital should meet the requirements of the NABH and therefore all personnel involved should be trained to achieve the required quality standards. In this regards he said that the hospital had to conduct some sensitization programs and as per the advices from the quality managers it was planned to hold Sensitization on hospital safety aspects for the supporting staff. Members felt the sensitization process quality issues an integral component in NABH accreditation, hence appreciated the move.

Resolution: Members felt the sensitization process quality issues an integral component in NABH accreditation and appreciated the move.



Medical education technology workshop on CBME
