* In case of single occupancy, Senior Resident - Rs.14,000/-, MBBS Tutor - Rs.10,000/- and AHS Tutor - Rs.5,000/- shall be charged.

Note:

1. A refundable **Caution Deposit** of Rs. 1,00,000/- shall be collected from Medical students and Rs. 20,000/- from Allied and Health Professions students at the time of Hostel admission.
2. The revised fees shall be applicable for all admissions and renewals for the Academic Year 2026-27.
3. Hostel residents shall remit the prescribed fees within the stipulated timelines communicated by the respective hostel authorities.
4. All other hostel rules and regulations shall remain unchanged.
5. The decision of the University authorities regarding hostel fee matters shall be final and binding.
