NOTIFICATION

The following declaration made by a resolution passed at a meeting of the Executive Committee of Indian Nursing Council held on 31st October, 2023 under section 10 of the Indian Nursing Council Act, 1947 (XLVIII of 1947) is hereby published, as required by Sub-section (1) of Section 15 of the said Act, namely: -

Recognition of the Basic B.Sc. Nursing, Post Basic B.Sc. Nursing and M.Sc. Nursing qualifications granted by the Sri Devraj URS Academy of Higher Education & Research, Deemed to be University, Tamaka, Kolar, Karnataka on or after 31st October, 2023.

WHEREAS, "Sri Devraj URS Academy of Higher Education & Research, Deemed to be University, Tamaka, Kolar, Karnataka" being an authority recognized by the Government of India, Ministry of Human Resource Development vide Notification No. F.9-36/2006-U.3(A) dated 25.05.2007 and UGC letter no. F.8-28/2006(CPP-1) dated 20.06.2007 for granting Basic B.Sc. Nursing, Post Basic B.Sc. Nursing and M.Sc. Nursing qualifications has applied to the Indian Nursing Council constituted under the INC Act, 1947 (XLVIII of 1947) as amended from time to time that the qualifications granted by it in Basic B.Sc. Nursing, Post Basic B.Sc. Nursing and M.Sc. Nursing qualifications be recognized for the purpose of the said Act subject to the following condition from 31st October, 2023 onwards:

- No distance education under Nursing can be offered by the University.
- No Nursing program including Ph.D (N) can be offered without the permission of Indian Nursing Council.
- Only those programmes / qualifications shall be offered which are prescribed / recognized by INC. Just changing the nomenclature of the courses i.e. Home care provider etc. shall not be offered by the University.
- Nursing Faculty shall be a member of examination/Academic Board/Council.
- Faculty of Nursing should be independent and not under the Faculty of Science/Faculty of Medicine.
- The copy of examination schedule shall be provided to INC every year.
- Indian Nursing Council may conduct the inspection during the period of examination.
- Medium of instruction shall be English.
- Designation and experience of the Nursing Faculty shall be as per INC norms.
- University shall be inspected physically to assess the suitability of courses of study and training for the purpose of grant of recognition of qualification under Section 10, 13 & 14 of INC Act, 1947.

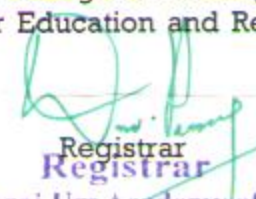

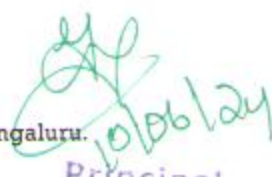
